FIRST NOTICE OF FIRST PUBLIC MEETING

To be held by Windsor Solar LP regarding a Proposal to Engage in a Renewable Energy Project

Project Name: Windsor Solar Project

Project Location: Within the Your Quick Gateway (YQG) Windsor International Airport property, City of Windsor.

Dated at: The City of Windsor this 27th day of May 2014.

Windsor Solar LP is planning to engage in a renewable energy project in respect of which the issuance of a renewable energy approval (REA) is required. The proposed Windsor Solar Project would be located on lands within the Windsor International Airport, which is owned by the City of Windsor and operated by Your Quick Gateway (Windsor) Inc. (YQG).

The distribution of this notice of a proposal to engage in this renewable energy project and the project itself are subject to the provisions of the *Environmental Protection Act* (ACT) Part V.0.1 and Ontario Regulation 359/09 (Regulation). This notice must be distributed in accordance with section 15 of the Regulation prior to an application being submitted and assessed for completeness by the Ministry of the Environment.

Project Description:

Pursuant to the Act and Regulation, the facility, in respect of which the project is to be engaged in, is considered to be a Class 3 Solar Facility. If approved, this facility would have a total maximum name plate capacity of 50 MW. The project location is described in the map below. All components will be located within the project boundary area as shown in the map.

Documents for Public Inspection:

This project is being proposed in accordance with the requirements of the Act and Regulation. The Draft Project Description Report has been prepared, and provides details on the project, including information on the solar PV technology and associated project components and activities.
